

## PRESS RELEASE EuroACE – Energy Efficient Buildings reactions on: 'Fit for 55 Package: Delivering the EU Green Deal' Brussels, 14<sup>th</sup> of July 2021



EuroACE – Energy Efficient Buildings welcomes the publication by the European Commission of its Fit for 55 (FF55) 'July Package'. Welldesigned and fully interconnected EU legislation will be the main driver for the achievement of the EU goals to transform our building stock to be highly energy efficient and decarbonised.

"Within the FF55 Package, the Energy Efficiency Directive is the piece of legislation that lifts the

bar of ambition when it comes to a more efficient energy performance of our buildings and our energy systems. We welcome the proposed binding EU headline target that aims at reducing by 39% the EU's primary energy consumption by 2030, along with the more ambitious energy savings obligations set out in the new Article 8" says Adrian Joyce, Secretary General of EuroACE.

"The strengthening of the renovation requirement in the new Article 6 to now cover all buildings owned by public bodies and requiring them to reach NZEB levels is a big leap forward and one that can really help create scale. What's key now is to ensure a similarly high level of ambition and coherence for the revision of the Energy Performance of Buildings Directive (EPBD) later this year" says Julie Kjestrup, Danfoss, President of EuroACE.



Indeed, "The FF55 Package provides a roadmap for accelerating renovation, but much more work is needed to win the decarbonisation race for buildings. EuroACE members are ready for the legislative marathon and help make energy efficient, healthy and comfortable buildings a reality for all Europeans", added Céline Carré, Vice-President of EuroACE.

EuroACE also welcomes the introduction, in Article 11, of an obligation for high energy-using enterprises to implement energy management systems (EMS), although we regret that the energy audit requirement will only be applied to lower-energy using enterprises, if an EMS is not in place. Energy audits are an underused tool that can ensure more efficient energy performance in buildings if their recommendations are implemented in a short timeframe. This is a requirement that should be added to the EED and could be exploited to create mutually beneficial linkages with the EPBD.







Finally, EuroACE notes that a new standalone Emissions Trading System (ETS) for buildings is being proposed as part of the FF55 Package, along with a new element, the Climate Social Fund (CSF).

This instrument raises many questions, and it will have to be carefully designed to support the goals of the Renovation Wave. The CSF intends to create a



'social safeguard', especially for vulnerable consumers and for the energy poor that will be impacted by the increase in fuel prices caused by the new ETS for buildings. EuroACE believes that this Fund should be channelled into the energy renovation of buildings, and it should be established and operational well before the start date of the new ETS in 2025.
